In 1994, Marc de Jong then moved to Philips Automotive, where he initially worked in various management and executive positions before taking charge of the Lamps EMEA division and subsequently the Special Lighting division at Philips Lighting as CEO starting from 2003. In 2005, Marc de Jong joined NXP Semiconductors in the position of CEO of BG Automotive & Identification. After working at NXP for five years, he returned to Philips and, among other things, managed its Professional Lighting Solutions division as CEO. Since 2013, he has been the owner and CEO of InnoMarket BV. From 2015 to 2018, Marc de Jong took on the role of CEO of LM Wind Power, a Danish global market leader in rotor blades for wind turbines with 11,000 employees worldwide and annual sales of 1,7 billion USD. LM Wind Power was PE backed and under Marc de Jong's leadership sold to General Electric. He left the company after having managing the successful integration.

Alfred Gossner has studied economics, econometrics and political sciences at the Ludwig-Maximilians-University in Munich and the University of Lancaster. In parallel, he also studied philosophy at the Munich School of Philosophy. Following his degrees in economics and philosophy, he completed a two-year research residency as a Rhodes Scholar at the University of Oxford. After, Alfred Gossner was a research assistant and academic advisor at the Faculty of Economics of Munich University and finished his PhD there. He started his career at an international business consultancy in 1983 subsequently. This was followed by sixteen years, starting from 1985, in various management positions at the Allianz Group, including as Group Managing Director (CEO) of Allianz South Africa, Johannesburg, and Allianz Namibia, Windhoek. Back in Germany, he took up the position of Chairman of the Executive Committee of Allianz Northern Germany in 1996 before being appointed as a member of the Management Board of Allianz Versicherungs-AG in 1999. In 2002, Prof. Gossner moved to the Management Board of Fraunhofer-Gesellschaft, where he was responsible for the areas of finance, controlling, IT, purchasing as well as real estate management and construction until the end of 2017. Additionally, from 2008 until the end of 2018, he was appointed to the board of Fraunhofer-Zukunftsstiftung where he was responsible for the commercial management. As a member of the executive committee he represented the Fraunhofer Gesellschaft in leading the global research alliance and especially supervised Fraunhofer research activities and partners in countries of the southern hemisphere for many years. In 2010, he was appointed as "Professor Extraordinary" at the Business School of Stellenbosch University in South Africa. In the year 2017, he got elected as President of the Munich Business School (starting in 2018). In his role as Chairman of the Supervisory Board of First Sensor AG, Prof. Gossner can also make use of his experience from former supervisory and advisory board mandates for Germanische Lloyd AG, Karstadt Warenhaus AG, the ThyssenKrupp Group as well as various financial groups.
